**2. Salary (Consolidated):**

**3. Qualification**

- a. The candidates must have passed the CA INTER examination for Chartered Accountants on or, before March 1, 2013.  
b. Work experience shall be counted after the completion of desired educational qualification on **01/10/2013**. The work experience required shall be 3 years.  
c. Candidates must have knowledge of computer proficiency & Tally Package.

**4. Terms of Employment:**

The post would be purely on contract basis, initially for the period of 3 yrs., and renewed based on the satisfactory performance of the candidate.

**5. Age Criteria / Relaxation:**

- a. Maximum age as indicated above should be calculated on **01/01/2016**.  
b. OBC Candidates shall get age relaxation of 3 years in maximum age limit. They will have to produce necessary certificates from competent authority, in this respect.  
c. SC/ST Candidates shall get age relaxation of 5 years in maximum age limit. They will have to produce necessary certificates from competent authority, in this respect.  
d. PHP (Physically Handicapped Person) Candidates shall get age relaxation of 10 years in maximum age limit. They will have to produce necessary certificates from competent authority, in this respect.
